The other referee must normally be a holder of a British citizen passport and either a professional person or over the age of 25 (but see also page 7 of the guide).

- they are not employed by the Home Office;
- they have not been convicted of an imprisonable offence during the last 10 years (unless conviction has become spent under the Rehabilitation of Offenders Act 1974);

- they will advise the Home Office of any reason why the applicant should not be naturalised.
